In 2014, more than 1,750 animals received vital services from the Shelter. This includes 489 animal adoptions, 449 dogs and cats spayed or neutered, 393 microchips implanted, 453 animals vaccinated for rabies, 230 animals rescued from overpopulated regional animal shelters and over 10,000 pounds of food distributed through our Paws for Hunger partnership with The Hunger Coalition. The Animal Shelter of the Wood River Valley is funded almost entirely by private donations & grants. The Shelter has adopted out almost 12,500 animals. The Animal Shelter of the the Wood River Valley is continually connecting people and animals within and beyond our community.
