In 2016, more than 3500 animals received vital services from the Shelter. This includes 629 animal adoptions, 875 animals spayed or neutered, 227 lost or impounded pets reunited with their families, 289 animals rescued from overpopulated regional animal shelters and over 1075 bags of food provided through the Paws for Hunger pet food bank. In addition, more than 1100 children participated in youth education programs through the Shelter's outreach efforts and more than 12,000 volunteer hours were recorded.

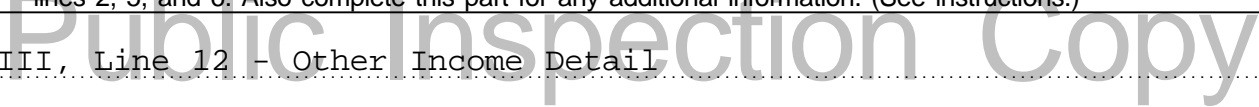
