**In 2017, more than 3500 animals received vital services from the Shelter. This includes 622 animal adoptions, 360 animals spayed or neutered, 278 lost or impounded pets reunited with their families, 382 animals rescued from overpopulated regional animal shelters and over 1004 bags of food provided through the Paws for Hunger pet food bank. In addition, more than 993 children participated in youth education programs through the Shelter's outreach efforts and approximately 19,000 volunteer hours were recorded.**
